## Moonlight Gala Raises More Than \$300,000 for Crystal Cove Alliance

*Memorable evening under the stars raises critical funds

**NEWPORT COAST, Calif., Sept. 29, 2015** – More than 400 guests gathered on the bluff overlooking Crystal Cove as a magnificent sunset gave way to a brilliant full moon at the [Crystal Cove Alliance \(CCA\)](#) 13<sup>th</sup> annual “[Moonlight Gala](#)” presented by [The Resort at Pelican Hill](#) on Saturday, Sept. 26. The sold-out event raised more than \$300,000 in support of the nonprofit’s commitment to protect and preserve the cultural, natural and historic resources of [Crystal Cove State Park](#).

The night unfolded with an al fresco cocktail hour with hors d’oeuvres provided by [Fig and Olive](#) and a silent auction filled with highly desirable items. Guests then enjoyed a delectable three-course meal prepared by The Resort at Pelican Hill followed by a live auction and a multi-media program highlighting CCA’s successes throughout the year and a sneak peek into future initiatives. Grammy Award-winner David Foster’s newest protégé, jazz singer [Brenna Whitaker](#), provided the evening’s entertainment as her soulful voice carried through the night.

This year's goal is to reach 5,000 students from all over Southern California.

Crystal Cove Alliance (CCA), the official nonprofit partner of Crystal Cove State Park, is dedicated to preserving the cultural, natural and historic resources of Crystal Cove. Founded in 1999 by Laura Davick to stop a planned luxury resort from overtaking the area, CCA rescued the historic site and initiated one of the most successful public-private partnership models in the history of the California State Park system.

Today, CCA has expanded its focus to include all 3.2 miles of pristine coastline, more than 3,700 acres of backcountry habitat and 1,100 acres offshore in the Underwater Park. CCA has turned Crystal Cove into a laboratory for developing innovative educational programs and experiences that promote science and environmental literacy to more than 1.5 million visitors and students each year. CCA's conservation work insures access by a range of recreational enthusiasts while maintaining protection of critical habitat and protecting endangered and threatened species.

The partnership between Crystal Cove State Park and the Crystal Cove Alliance has led to the renovation of 29 historic beachfront cottages now open for overnight stays, as well as historic education programs designed for the public. CCA is proud of the park receiving the prestigious 2007 Governor's Award for Historic Preservation. A leader in fundraising, restoration, education and concession services, CCA is devoted to creating a sustainable future for Crystal Cove. Seventeen historic cottages remain to be restored.
