Nominations Open for EY Entrepreneur Of The Year® Orange County Awards



Additionally, the nominee's company must be at least two years old. Entrepreneurs may nominate themselves or be nominated by peers and other business partners. Self-nominations are encouraged, and there is no fee to apply. Award winners are selected by a panel of independent regional judges composed of previous award winners, leading CEOs, private capital investors and other local business leaders. One national winner will go on to vie for the EY World Entrepreneur Of The YearTM title in Monaco the following June.
